## 57/23-24 <u>Tesco Employability and English as a Second Language (ESOL) Workshops</u>

Back in May Council had a letter from Staffordshire CC announcing the creation of a dedicated post, in partnership with Staffordshire Parish Councils' Association (SPCA), to support Councils seeking to improve the health & wellbeing of their communities. (LGA S137). This was followed up in July with the introduction of the Health & Wellbeing Officer at the SPCA who introduced Tesco's as potential collaborator.

In the absence of confirmation from Tesco's of the precise nature of the collaboration, the Clerk and Cllr Codie had sketched out some initial costings. Council was accepting of the need and supportive of the collaboration proposal and the resolutions passed were:

<u>Employability Workshops:</u> For the delivery of a series of 10 x 3-hour workshops (October to December) for up to 12 parishioners (accessed via the local Job Centre) and delivered by Cllr S Codie supported by Cllr N Nadeem (on a voluntary basis) Council will fund the room hire, stationery and other incidental costs up to £500.

<u>ESOL Workshops</u>: For the delivery of something structured to mirror the above but with the addition of a qualified ESOL instructor funding of up to £500 plus an additional £1,000 to fund the instructor, £1,500 in total.
